IN RE: ASSIGNMENT AND COURT SERVICE SCHEDULE IN JUDICIAL ELECTION DISTRICTS 5A AND 5B FOR 2024

### **ADMINISTRATIVE ORDER 2023-29**

The Iowa Supreme Court has authorized a reasonable travel budget for F.Y. 2024. However, travel expenses will be closely monitored by Court Administration. The assignment set forth herein is subject to modification as budget constraints require.

### NOW THEREFORE IT IS HEREBY ORDERED:

- 1. <u>Rotations</u>. Beginning Monday, January 1, 2024, trial sessions and rotations for the first and second quarters of 2024 in Election Districts 5A and 5B shall be held in accordance with the schedule marked Exhibit "A" attached hereto and by this reference incorporated herein.
- 2. Trial Dates. Civil and criminal jury trials in Election Districts 5A and 5B shall be scheduled to commence on the days set forth in Exhibit "B" attached hereto and incorporated herein. Jury and non-jury trials shall also be assigned at other times to fully utilize available judges and facilities. Trials in Election Districts 5A and 5B shall be scheduled up to 6 cases deep depending on the availability of cases. All trial dates shall be considered firm. There shall be no leadoff or standby cases. Court Administration shall not bump a case for lack of an available judge, court reporter or courtroom. In such situations, only the Chief Judge or the Assistant Chief Judge shall decide whether to bump a case for lack of available resources.
- 3. <u>Court Service Schedule.</u> Court Service Day shall be held in every county of the Fifth District as set out in Exhibit "C" attached hereto and incorporated herein. If the Court Service Days ordered herein are inadequate to handle the business of any county, court administration may schedule additional Court Service Days on an as needed

basis. Conversely, if weekly court service is unnecessary in any county, court administration may schedule short non-jury trials on Court Service Days. Court Service Days may be cancelled by the Chief Judge upon the request of the local judge or the clerk of court. The Court Service Day schedule for Taylor County is assigned as Exhibit "D" attached hereto and incorporated herein by reference.

4. <u>Utilization of Judges.</u> Court Administration shall at all times fully utilize all of the Judges of the Fifth Judicial District without regard to judicial election district boundaries. Court Administration shall assign judges efficiently and monitor travel expenses on a monthly basis.
