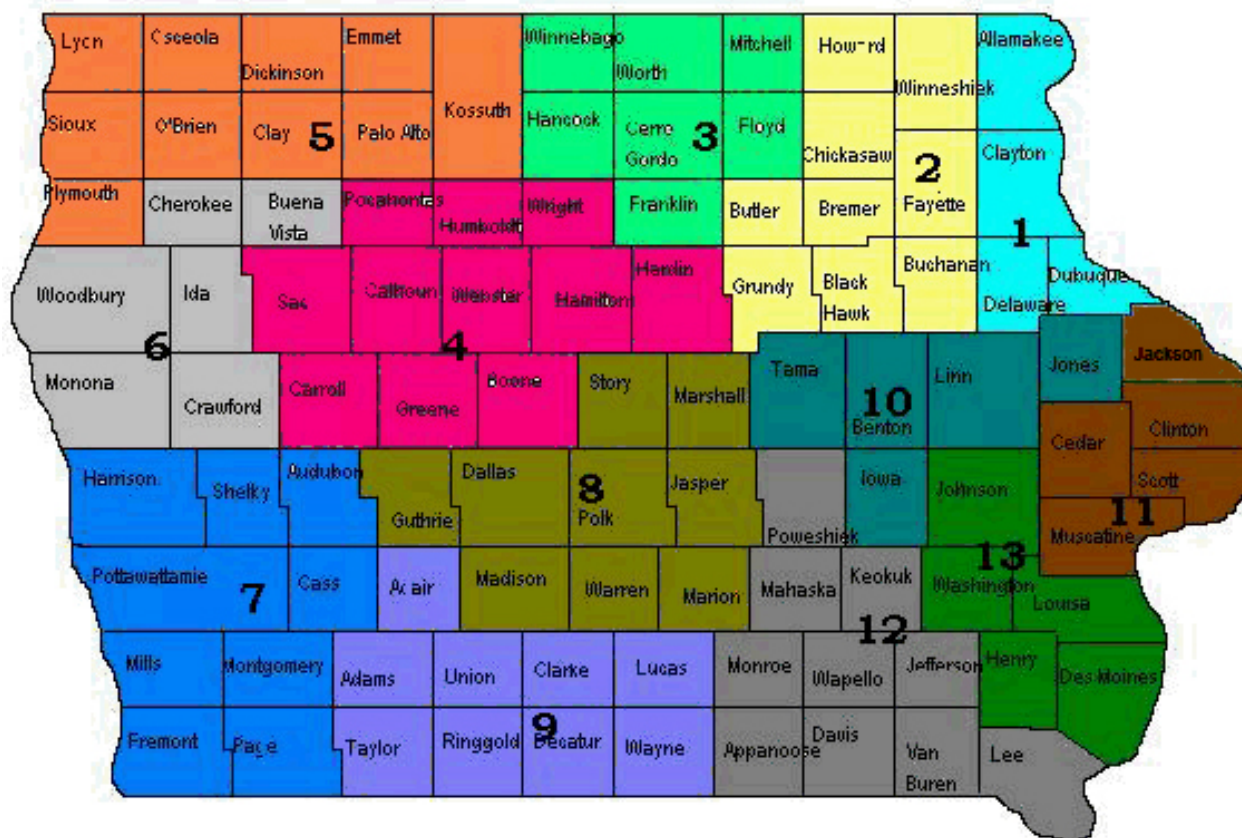


## Directory of Media Coordinators
