ADMINISTRATIVE ORDER 2012 - #3

WHEREAS on Tuesday, April 3rd, 2012, District 3A by majority vote pursuant to Iowa Code Sections 602.1209 and 602.1215 did appoint Stephanie Wollmuth of Sibley, Iowa, to be the Clerk of the District Court for Lyon County and Osceola County. Stephanie Wollmuth will be the Acting Clerk of Court for Lyon County and Osceola County pending the successful completion of a course of education and training as specified by the state court administrator.

Such course costs will be paid by the Iowa Judicial Branch and are to be completed in the course of Stephanie Wollmuth's official work duties as an employee of the Judicial Branch.

Upon presentation of the documentation demonstrating successful completion of the Applied Management certification program and the *Fundamentals of Supervision* course to the Chief Judge an Administrative Order shall be issued confirming the appointment action of the Election District 3A District Court Judges naming Stephanie Wollmuth Clerk of the District Court for Lyon County and Osceola County.

THEREFORE, IT IS HEREBY ORDERED that Stephanie Wollmuth is appointed Acting Clerk of the District Court for Lyon County and Osceola County effective April 4, 2012.

IT IS FURTHER ORDERED that Stephanie Wollmuth is empowered to perform all the duties and responsibilities of the position of Clerk of Court for Lyon County and Osceola County, Third Judicial District in her interim capacity.


