Administrative Order No. 2014-3

The Electronic Document Management System (EDMS) is scheduled to be activated for the Wapello County District Court on November 4, 2014. In anticipation of said system being implemented in the Wapello County District Court, it is necessary for court staff to receive training. This training is mandatory. In order to ensure that said training is completed, it will be necessary for the Clerk's office to be temporarily closed on several occasions for the staff to prepare and train for the EDMS implementation.

IT IS THEREFORE ORDERED that the Wapello County Clerk of Court's office shall be closed to the public from 1:30 p.m. to 4:30 p.m. on the following dates: October 7, 2014; October 14, 2014; October 16, 2014; October 21, 2014; and October 23, 2014.

The Clerk shall ensure that this notice is conveyed to the public by posting this notice prominently at the Wapello County Courthouse. The Clerk shall also ensure that notice of said closure of her office is conveyed to attorneys regularly practicing in Wapello County, local law enforcement, and any other individuals who regularly utilize the services of the Clerk's office. The Eighth Judicial District Court Administrator shall also ensure that a copy of this notice is posted on the Judicial Branch website.
