IT IS HEREBY ORDERED that for calendar year 2016, District Court Judges of Judicial Election District 5-C (Polk County) are assigned to Polk County benches as follows:

Judges assigned to Felony Criminal Trials shall occupy courtrooms 208 and 209A by seniority courtroom selection protocol. Judges assigned to the Criminal Dockets may be assigned elsewhere as needed.

DOMESTIC-FAMILY BENCH: Arthur E. Gamble
Eliza J. Ovrorn

Judges assigned to Domestic-Family Bench shall occupy Courtroom Nos. 412 and 413 by seniority courtroom selection protocol.

The Domestic-Family Bench shall, to the extent possible, preside over all dissolution and modification proceedings, annulments, paternity actions, child support recovery proceedings, Chapter 236 domestic abuse proceedings, child custody, private termination of parental rights and adoption proceedings excluding Chapter 232 proceedings where the petitioner is the Department of Human Services, a Juvenile Court Officer or the County Attorney. The judicial responsibility and workload of these two judges shall be fairly divided between them so that the needs of litigants and their attorneys are well served.

INTENSIVE SUPERVISION DRUG COURT:

The judge assigned to the Intensive Supervision Drug Court shall occupy Courtroom 302. For 2016, Judge Lawrence P. McLellan is assigned to Intensive Supervision Drug Court and Courtroom 302.


