82% (47) of all those taking the exam for the first time passed

67% (10) of those taking the exam from University of Iowa took the exam for the first time

100% (10) of those taking the exam from University of Iowa for the first time passed

61% (14) of those taking the exam from Drake University took the exam for the first time

79% (11) of those taking the exam from Drake University for the first time passed

22% (2) of those taking the exam from Creighton Univ. took the exam for the first time
