Referencing Admin. Order 2015-55

Administrative Order 2015-55 sets out the Court Service schedule for Election Districts 5A and 5B. Adair and Ringgold Counties are to hold Court Service every other Monday opposite each other.

Effective Monday, February 1, 2016, Ringgold County will have Court Service and Monday, February 8, 2016 Adair County will have Court Service, rotating every other week throughout the year.

ADMINISTRATIVE ORDER 2015-55

The Iowa Supreme Court has authorized a reasonable travel budget for F.Y. 2016. However, travel expenses will be closely monitored by Court Administration. The assignment set forth herein is subject to modification as budget constraints require.

NOW THEREFORE IT IS HEREBY ORDERED:

1. Rotations. Beginning Monday, January 4, 2016, trial sessions and rotations in Election Districts 5A and 5B shall be held in accordance with the schedule marked Exhibit "A" attached hereto and by this reference incorporated herein.
2. Trial Dates. Civil and criminal jury trials in Election Districts 5A and 5B shall be scheduled to commence on the days set forth in Exhibit "B" attached hereto and incorporated herein. Jury and non-jury trials shall also be assigned at other times to fully utilize available judges and facilities. Trials in Election Districts 5A and 5B shall be scheduled up to 6 cases deep depending on the availability of cases. All trial dates shall be considered firm. There shall be no leadoff or standby cases. Court Administration shall not bump a case for lack of an available judge, court reporter or courtroom. In such situations, only the Chief Judge or the Assistant Chief Judge shall decide whether to bump a case for lack of available resources.
3. Court Service Schedule. Court Service Day shall be held in every county of the Fifth District as set out in Exhibit "C" attached hereto and incorporated herein. If the Court Service Days ordered herein are inadequate to handle the business of any county, court administration may schedule additional Court Service Days on an as needed basis. Conversely, if weekly court service is unnecessary in any county, court administration may schedule short non-jury trials on Court Service Days. Court Service Days may be cancelled by the Chief Judge upon the request of the local judge or the clerk of court.

4. Utilization of Judges. Court Administration shall at all times fully utilize all of the Judges of the Fifth Judicial District without regard to judicial election district boundaries. Court Administration shall assign judges efficiently and monitor travel expenses on a monthly basis.

Effective Date. This Order shall be effective January 4, 2016.

Dallas:

- Court Service – Civil on Tuesday, Criminal on Friday (2 judges both days)
- Juvenile Court Service on the 1st & 3rd Wednesday, Contested on the 2nd & 5th Wednesday

Decatur:

- Court Service every Friday
- Juvenile Court Service on the 4th Monday of the month

Guthrie:

- Court Service on Monday (a.m. Criminal/p.m. Civil)
- Juvenile Court Service on the 4th Wednesday of the month

Jasper:

- Court Service on Monday (a.m. Criminal/p.m. Criminal motions and CSRU); Civil on Tuesday (a.m. Family Law, Civil & DA's/p.m. scheduled hearings & temporary matters as scheduled by Rural Case Coordinator)
- Juvenile Court Service on Friday

Lucas:

- Court Service on Monday
- Juvenile Court Service on the 4th Friday of the month

Madison:

- Court Service on Monday (a.m. Criminal/p.m. Civil)
- Juvenile Court Service on Thursdays as scheduled by the judge

Marion:

- Court Service Thursday (Family Law, Civil & DA's); Friday (a.m. Criminal and CSRU/ p.m. Criminal motions and CSRU hearings scheduled by the judge)
- Juvenile Court Service on Wednesday

Ringgold:

- Court Service every other Monday
- Juvenile Court Service on the 2nd Friday of the month

Taylor:

- Court Service on Tuesday except Juvenile day
- Juvenile Court Service on the 2nd Tuesday of the month

Union:

- Court Service on Friday
- Juvenile Court Service on the 2nd Thursday of the month

Warren:

- Court Service – Monday (a.m. Criminal/p.m. Criminal motions & CSRU); Tuesday (a.m. Family Law, Civil & DA's/p.m. scheduled hearings & temporary matters as scheduled by Rural Case Coordinator)
- Juvenile Court Service: Wednesdays – Delinquencies & CINA, Thursdays – Delinquencies & CINA

Wayne:

- Court Service every other Tuesday
