Amendments to Iowa Court Rule 31.16 – Registration of House Counsel

As requested by the Iowa Supreme Court's Order dated June 2, 2020, which solicits public comment on the Proposed Amendments to Iowa Court Rule 31.16 – Registration, we write to express our strong support for the proposed Rule amendments. Because we employ a significant number of house counsel at our respective companies, these proposed amendments are important for us and the attorneys who play such a crucial role in our businesses.

Specifically, the amendment to Rule 31.16(9)(10), lines 16-28 (page 2 of 3), which addresses removal of the 5-year limitation on house counsel registration status for attorneys licensed in another jurisdiction, will (1) serve to bring Iowa into conformity with how other jurisdictions treat house counsel registration. (2) simplify and expedite employment of in-house counsel at Iowa businesses, and (3) allow domestic lawyers to benefit from the same unlimited duration on their registration as foreign lawyers have received. And, the amendment to Rule 31.16(10)(11), lines 1-8 (page 3 of 3), which would remove the 5-year limitation on the duration of house counsel status for attorneys currently subject to that limitation, further facilitates the intent of the amendment to Rule 31.16(10), making it easier for our attorneys to maintain their house counsel status.

We appreciate this Court's ongoing attention to and revision of the Rules relating to Iowa Bar Admission, which both contributes to the strength of our local Bar and facilitates our ability to attract and retain our legal talent.
