With this order, the supreme court establishes the Iowa Rules of Appellate Procedure Review Task Force. The most recent complete review of the Iowa Rules of Appellate Procedure concluded in 2008. The task force will undertake a comprehensive review of the appellate rules. The review will include analysis of all rules, forms, and timetables in chapter 6 of the Iowa Court Rules.

The task force will submit a final report to the court on or before April 1, 2022. The final report will include the task force's findings as well as any recommendations for amending and updating the rules.
