**Subject:** New and Updated Event Codes and updated Role Code

### New Event Codes

#### ***ASXM - APPLICATION TO MODIFY SEX OFFENDER REGISTRY – 692A.128***

- There is no fee required when filing to apply for modification of the sex offender registry.
- The new event code enables the defendant to file a new civil case without a filing fee.
- It is available to file on criminal cases as well.
- Currently, defendants filing a petition into the existing criminal case or a new civil case are not required to pay a filing fee.
- Previously, defendants filing a new civil case when the existing criminal case was out of county were charged a filing fee for the application.

#### ***CNTA – APPLICATION/INITIATE CONTEMPT – ABUSE***

- Use for filing contempt action in Domestic Abuse, Sexual Abuse, Elder Abuse case types without charging a filing fee.

#### ***FACA – FIREARMS COMPLIANCE AFFIDAVIT***

- Created for the new Firearms Compliance Affidavit form available at [Court Forms | Iowa Judicial Branch \(iowacourts.gov\)](https://www.iowacourts.gov/court-forms) under Domestic Abuse or Violence, Elder Abuse, Mental Health or Sexual Abuse folders.
- Defendants under Final Protective Orders pursuant to 18 U.S.C 922(g) and Iowa Code section 724.26 who are prohibited from possessing firearms, offensive weapons, or ammunition are required to file this affidavit with the court in the county where the protective order was issued.
- Event code is available under Criminal, Domestic Abuse, Elder Abuse, Mental Health, or Sexual Abuse case types.

#### ***FATA – FIREARMS TRANSFER AFFIDAVIT***

- Created for the new Firearms Transfer Affidavit form available at [Court Forms | Iowa Judicial Branch \(iowacourts.gov\)](https://www.iowacourts.gov/court-forms) under Domestic Abuse or Violence, Elder Abuse, Mental Health or Sexual Abuse folders.
- Recipients who are accepting any firearms, offensive weapons, or ammunition from and on behalf of a defendant whom the court prohibited from owning or possessing said items under a Protective Order are to submit this affidavit.

- Event code is available under Criminal, Domestic Abuse, Elder Abuse, Mental Health, or Sexual Abuse case types.

### **Event Code Updated**

#### ***DAIN – INFORMATION SHEET FOR PROTECTIVE ORDER REGISTRY***

- Changed from DAIN - DOMESTIC & SEXUAL ABUSE REGISTRY & PROTECTIVE ORDER INFO to DAIN – INFORMATION SHEET FOR PROTECTIVE ORDER REGISTRY.
- The description was changed because the event code can be used in any case type where a protective order was issued.

### **Role Code Updated**

#### ***JVMO – JUVENILE MOTHER***

- Removed security 1 access on all case subtypes except Juvenile and Juvenile Guardianship.
- JVMO will be level 0 on all other case types.
- Persons should be indexed in accordance with the manuals to ensure proper case access.

#### ***JVFA – JUVENILE FATHER***

- Removed security 1 access on all case subtypes except Juvenile and Juvenile Guardianship.
- JVMO will be level 0 on all other case types.
- Persons should be indexed in accordance with the manuals to ensure proper case access.
