### Children Cope with Divorce

- Only court approved course for divorcing & unmarried parents in IA District 3.
- Meets IA code 598.15
- Required by South Dakota Supreme Court Rule 22-09.
- Attendance is mandatory for both parents in all cases involving child custody or child visitation, including modification of custody & physical care.
- Parents may attend together or separately.

### Overview

This zoom course is designed to educate divorcing parents on how to minimize the negative impact of their separation on their children, particularly when adults are dealing with their own challenges related to the divorce. This 3-4 hr. session teaches strategies to support children's emotional well-being during this transition period. The course assists parents in redefining their relationship & developing suitable plans for their children.

### Child-centered approach

The primary goal of this course is to equip parents with the knowledge & skills to prioritize their children's needs during the divorce process.

### Educational content

This course covers topics like open communication with children, managing emotional responses, maintaining consistent routines, & navigating co-parenting dynamics.

### Participant expectations

- Participants must register & pay online.
- Participants must be logged in & present on camera before the class begins.
- Participants must return to class on time after scheduled breaks.
- Participants must be actively engaged in class.
- Participants must have child care arranged & be in a quiet location so that they can give their full attention to the material presented.
- Classes of five or less students are subject to rescheduling.
- Participants will be notified 24 hours in advance of any cancellations.
