COVID-19 EMERGENCY**


Administrative Order 2020-4

The undersigned on October 10, 2019, issued an Order pursuant to Iowa Court Rule 22.8 establishing the times and places that the district court would hold court in the Eighth Judicial District. The Iowa Supreme Court has issued Orders which have resulted in court hearings being reduced and delayed due to the Covid-19 emergency. The Iowa Supreme Court has also issued orders setting the dates when regular court hearings and trials may be recommenced. Because of this, it is necessary that the district court service day schedule and criminal jury trial schedules be adjusted so as to accommodate the anticipated increased workload once court proceedings are recommenced.

Attached hereto and made a part of this order is the revised district court service day schedule for the month of June 2020 and the revised district court criminal jury trial schedule.

The clerks in each county shall provide a copy of this order and the revised schedules to all attorneys practicing in their county.
