Registering for Advanced Search

The information available on Iowa Courts Online Search is not considered an official court record. If you find errors during an Iowa Courts Online search, inform the clerk of court of the corresponding district court.

Making Payments

If you cannot find your citation or ticket

- Your citation may not yet be added to Iowa Courts Online—it can take up to 14 days.
- Your parking ticket could be from a city, not a county. Only tickets filed with the county clerk of court are available on Iowa Courts Online.
- Your name could be spelled incorrectly on the court record. Try typing only the first few letters of your first and last names.
- If you have changed your name, your citation may have matched to your previous last name, based on your birth date and driver's license/social security number. Try searching under a previous name.
- You could be entering the case number wrong.
 - It should have 17 characters.
 - The number 0 and the letter 0 are not interchangeable.

Iowa Courts Online Help

- Use capital letters for any letters in the case ID.
- The number 0 and the letter O are not interchangeable.
- Appellate case numbers do not have letters.
- Do not use first names in the short case title: Use last names only such as Doe v. Smith or State v. Jones.
- If you can't find a name, use fewer characters in case it was spelled wrong. For example, instead of typing *Dianna*, type *Di*.

Frequently Asked Questions

What does "no records found matching your search criteria" mean?

- Your citation may not yet be added to lowa Courts Online—it can take up to 14 days.
- Your parking ticket could be from a city, not a county. Only tickets filed with the county clerk of court are available on Iowa Courts Online.
- Your name could be spelled incorrectly on the court record. Try typing only the first few letters of your first and last names.
- If a law enforcement officer scanned your out-of-state driver's license/ID, your first and last name could have been switched accidentally. Try typing your first name in the last name field and vice versa.
- You could be entering the case number wrong.
 - It should have 17 characters.
 - Use the number 0 and the letter O correctly; they are easily confused.
- It could be a confidential case. Juvenile and other confidential cases are not available online.
- You might have entered extra spaces.
- The case is old and has not been added to the case management system.

Why doesn't the document I delivered to the clerk's office today appear in the case information?

The clerk's office generally enters documents into the case management system within a few days after receiving them. The delay in entering the document does not affect its timeliness.

What cases and case data is available?

- Only public information is available. Public docket information available at no charge includes basic case
 information such as case titles and filings, names of parties and lawyers, criminal charges, case
 disposition entries, child support payments, fine and fees owed, and fine and fee payments.
- Appellate case electronic documents can be viewed at a public access terminal at the courthouse, in the county where the appeal was filed.
- Trial case electronic **documents** may be viewed for that county at the public access terminal at the courthouse.
- Juvenile and other confidential case information is not available.
- All public trial cases after 1998 are available. Some earlier cases may be available electronically.
 Information on cases filed before 1998 can be obtained through the clerk of court in the county where it was filed.

All Iowa appellate court cases filed after June 1998 are available, except juvenile and other
confidential cases. Information on cases filed before June 1998 can be obtained through the
appellate court clerk's office.

• Case schedules, judgment index, lien index, exhibit lists, bonds, and service return information is available with a paid subscription.

How often is case data updated?

Cases added to the case management system take one business day to appear in the search results on Iowa Courts Online. After a case is in Iowa Courts Online, case data is updated in real time.

How do I see the details of a case?

In the Search results click on the blue hyperlink: either Case ID link (Trial) or Docket No. (Appellate).

On the Details page, there are hyperlinks across the top of the screen. Hyperlinks with brackets [] can be used without a paid subscription. Hyperlinks without brackets can be used at a public access terminal at the clerk of court's office, or require a paid subscription.

What if I need legal advice?

lowa law and ethical rules prohibit judges and court staff from giving legal advice. If you need legal help, look in the yellow pages of the phone book under "attorney" or "attorney's referral". You can find more information on the lowa Find-A-Lawyer referral service online or toll free 1 (800) 532-1108.

Who are registered users?

A registered user pays for an Online Search subscription. The Online Search subscription grants access to the Schedule Search and Trial Court Advanced Case Search. Registered users are sometimes called subscribers. You do not need to be a registered user to make payments.

What if I see information that is confidential?

You are not permitted to use or disseminate any information that is confidential by law, court rule, or court order. You only have permission to view case information that is available to the public. Your User Agreement requires you to immediately report the data breach by either raising a ticket at https://jbconnect.iowacourts.gov/support/home or contacting the clerk of court if you see any confidential information.

- You must specify at least two letters of the Last/Firm name.
- Be sure to spell the name as it is spelled in the case. All other fields are optional.
- To search by two names:
 - If both are in the case, select AND.
 - o If one or the other, but not both, are in the case, select OR.
- If you search by first name initial, do not enter a period after the initial.
- Be sure to spell the name correctly.
- You can use the % wildcard symbol to find every name that contains a string of characters. For example, %dan would return the name McDaniel.
- AND/OR:
 - Use AND for two names that must BOTH be in the results.
 - Use OR for two names when EITHER can be in the results.

Date of Birth Search

- The exact date of birth is required.
- The last name is required and cannot be wildcarded.
- The first name is required and cannot be wildcarded.
- The middle name is not required, but can be wildcarded. It will match entries where the database has a null middle name.



Registering for an Online Search Subscription

The Online Search subscription grants access to case schedules, judgment index, lien index, exhibit lists, bonds, and service returns. Registered users are sometimes called subscribers.

You DO NOT need to register or pay for a subscription in order to make a payment. See Making Payments

Security and Your Credit Card

We do not store your credit card information. When entering your credit card number on the registration form, do not use spaces or dashes. The name on the credit card does not need to match the email address provided on the registration form.

How to Register

To register, click **Register** on the bottom of the lowa Courts Online Search page.

Complete the form and press Submit.

Your user ID and your password must each contain 8 characters or less. Spaces are not allowed. It may contain upper-case characters, lower-case characters, and numbers.

How to Register Multiple Users

A firm, group, or business may register one account and share it between several people. If an account is shared, only one person may log on at a time.

If multiple people will use the system simultaneously, you must purchase multiple subscriptions. You may use one credit card to purchase multiple subscriptions.

Subscription Renewals

You may subscribe for one or more months. Subscriptions do not renew automatically. If you attempt to log on after your subscription has expired, you will be redirected to a "Subscription Renewal" page to reestablish your subscription.
