Juvenile Filings Guidance

Notes:

- ▶ When choosing "SOCIAL RECORD OTHER" as the EDMS Document Type, enter the name of the report or document as well as the date it was created in the "Additional Text" field when filing the document.
- ▶ Regardless of EDMS Document Type, when filing reports, include the date of the report in the "Additional Text" field when filing the document for the convenience of all case participants.
- Filers are encouraged to label all reports at the top of the first page of the report. For example, a child abuse assessment report should have a line at the top of the first page reading: "Child Abuse Assessment Report." This will assist clerks of court and case participants in identifying specific types of reports.
- ▶ When filing a document as a proposed exhibit, ensure that the first page of the filing identifies the exhibit number or letter, either with a filled-out exhibit sticker or text specifically identifying the exhibit number or letter of the document.
